Whole School Awareness Training

All staff in schools must access a Safeguarding Awareness Raising training session at least once every three years. This course is for all staff and is held within the school or college setting (can be delivered remotely during COVID-19 restrictions). It is usually a two-hour session and may be held on a teacher day or after school or a series of sessions can be arranged to flexibly meet the needs of all staff.

Our team of very experienced trainers can be booked to deliver this at a sessional charge of £200.

Experienced DSLs will have this resource available through their own training to enable them to deliver this course in-house.

Allegation Management

This half day course is mainly for head teachers, chairs of governors and senior staff with related responsibilities.

This course will give participants an understanding of their roles and responsibilities with regard to the handling of allegations about staff conduct, the role of the Local Authority Allegations Manager and safer working practices. The Allegations Manager / LADO, together with a representative from HR normally attend to comment and advise on current practice. Chairs of governors are very welcome as they will have to follow this process should their head teacher be the subject of an allegation.
